WAIVER AND RELEASE of LIABILITY

I understand that river and creek clean-ups are inherently dangerous activities and I am voluntarily participating in the Ukiah Valley Russian River and Ukiah City Creeks Clean Up 2017. I declare and acknowledge that I have, with full knowledge of all the risks and dangers of, voluntarily, and without the influence of any person, including the Event Sponsor, Hosts and Volunteer Organizers, fully and completely accepted and assumed all risks and dangers attributable to my participation in said activities.

I do forever voluntarily WAIVE, RELEASE AND DISCHARGE ALL CLAIMS OF LIABILITY for my death or injury or damage to my personal property and I agree to INDEMNIFY AND HOLD HARMLESS the Event Sponsors, Hosts, Volunteer Organizers, and participating landowners from all causes of action, judgments, liens, indebtedness, losses, claims, liabilities, expenses and demands of every kind and character. I further acknowledge that I intentionally and voluntarily waive the provisions of Section 1542 of the Civil Code of California, and that it is my intention that my release shall be considered for all purposes, a general release and shall apply to all claims and causes of action whether now known by me to exist in my favor or not.

This Waiver and Release shall be binding upon the heirs and successors in interest of the participant and any other person or entity making a claim based on personal injury, even if resulting in my death, or damage to my property which I may suffer while participating in the clean-up.

This Waiver and Release shall inure to the benefit of all persons succeeding to the interest of the Event Sponsor, Hosts, Volunteer Organizers and participating landowners.

I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND THAT I AM GIVING UP IMPORTANT LEGAL RIGHTS.
